Re: **Collective Bargaining Agreement with MAP 282 - Resolution R-155-12**

Issue: City staff and the Metropolitan Alliance of Police - Civilian Chapter #282 (MAP #282) have reached a temporary agreement for a successor collective bargaining agreement to the existing four-year collective bargaining agreement that expired on December 31, 2011 and was extended for six (6) months to June 30, 2012.

The City Council is scheduled to discuss the agreement at the Executive Session scheduled for 6 pm on December 17, 2012 Executive Session.

Recommendation: Assuming the City Council reaches consensus on the terms of a successor collective bargaining agreement with MAP #282, staff recommends adoption of Resolution R-155-12.

RESOLUTION R - 155 - 12

A RESOLUTION AUTHORIZING THE RATIFICATION AND EXECUTION OF THE COLLECTIVE BARGAINING AGREEMENT BETWEEN THE METROPOLITAN ALLIANCE OF POLICE, DES PLAINES CIVILIAN CHAPTER #282 AND THE CITY OF DES PLAINES, EFFECTIVE JULY 1, 2012 THROUGH DECEMBER 31, 2015.

WHEREAS, the City of Des Plaines and the Metropolitan Alliance of Police, Des Plaines Civilian Chapter #282 (MAP 282) have conducted good faith bargaining on issues related to wages, benefits, working conditions and other collective bargaining issues provided for in the Illinois Compiled Statutes; and

WHEREAS, the two parties have tentatively agreed to a collective bargaining agreement that outlines the terms and conditions related to those issues; and

WHEREAS, the terms and conditions of this Agreement are for the period July 1, 2012 through December 31, 2015;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Plaines, Cook County, Illinois, in the exercise of its home rule powers, as follows:

SECTION 1: That the recitals set forth herein above are incorporated herein by reference as the factual basis for this transaction.

SECTION 2: That the Mayor and City Clerk be authorized to execute the appropriate documents for the Collective Bargaining Agreement between the City of Des Plaines and the Metropolitan Alliance of Police, Des Plaines Civilian Chapter #282 (MAP 282) for the period of July 1, 2012 through December 31, 2015.

SECTION 3: That this Resolution shall be in full force and effect from and after its passage and approval according to law.
