- A. An Ordinance Expressing Official Intent Regarding Certain Capital Expenditures To Be Reimbursed From Proceeds Of An Obligation To Be Issued By The Village Of Lake Zurich, Lake County, Illinois (Assign Ord. 2015-10-091) (Trustee Stanovich)

Summary: The recent failure of the sanitary transmission line under East Cuba Road has proven to be a costly repair with estimates rising towards \$1 million at this point in time. As a large unbudgeted expense, Staff is proposing this Ordinance to allow the Village the flexibility for issuing debt to fund these repairs. The Ordinance states a maximum of \$1.5 million in principal, higher than the current estimates to allow for additional unknown expenses. Any actual debt would be issued for a final determined amount. The proposed Ordinance does not authorize the debt issuance or guarantee the Village will issue debt, but does provide the opportunity for debt issuance at a future date to cover expenses for this project.

**Summary:** The 2015-16 budget includes \$95,000 in the Capital Projects Fund for the roof replacement at Station 1. Four bids were received on September 8, 2015, ranging from \$69,900 to \$129,400 with All American Exterior Solutions as the lowest responsible bidder at \$69,900 with a 15% contingency. An additional \$30,000 is budgeted for an ice damming system to prevent future roof damage. The ice damming system will be presented separately to the Village Board at a future meeting date.

- C. **Approval to Waive the Bid Process and Purchase One LifePak Heart Monitor from Physio-Control an Amount Not-to-Exceed \$21,740.58**

**Summary:** The 2015-16 budget includes \$55,000 for the replacement of two LifePak Cardiac Monitor / Defibrillators. It is recommended at this point in the fiscal year that only one replacement LifePak be purchased. Physio-Control is the sole provider of this equipment and is being presented without a competitive bid process.

- D. **Proposal from Manhard Consulting for Civil Engineering and Surveying Services for Lining Certain Sections of the Sanitary Sewer Transmission Main in An Amount Not-to-Exceed \$68,750**

**Summary:** The 2015-16 budget includes funds in the Water and Sewer Fund and Capital Project Fund for engineering services related to the sewer lining project. Sections of the sewer have failed epoxy coating and eroding concrete. Preliminary construction estimates are between \$2.6 million to \$2.8 million. The engineering fee proposed by Manhard is approximately 2.5% of the total project cost.

Trustee Halen's questions were answered by staff on the agenda item #6B. Trustee Halen had a correction on the minutes of 9-8-15 and it was so noted.

8. **NEW BUSINESS**

A. **Memorandum of Understanding with Streetscape USA, LLC for Block A Redevelopment**

**Summary:** Streetscape USA has expressed interest in submitting a redevelopment proposal for detached, single family homes on the 1.675 acres of Village-owned property on Block A. The proposed Memorandum of Understanding will grant the developer the exclusive right to produce a redevelopment proposal by December 21, 2015 and to justify any requests for financial assistance. The developer will be present at the September 21 Village Board meeting to discuss the initial redevelopment concept proposal.

Mr. John McLindon of Streetscape USA gave a PowerPoint presentation on the proposed development of Block A.

Mayor Poynton gave the opportunity for public comments on the agenda item #8A.

B. **Courtesy Review for GW Properties on Proposed Redevelopment of the Former Giordano's Property at 455 South Rand Road**

**Summary:** GW Properties is under contract to purchase the former Giordano's restaurant at the southwest corner of Route 12 and Route 22. GW Properties has proposed the demolition of the existing building and the redevelopment of the site with a retail building that is approximately 8,500 square feet with space for three tenets. The property is nearly one acre in size with the proposed redevelopment likely to require zoning relief with reductions to building setbacks, landscaping, and parking requirements.

Mr. Mitch Goltz and Mr. Mark Digancy, of GW Properties, gave a PowerPoint presentation of their proposed development and they answered the Board's questions.

**Recommended Action:** Staff recommends the Village Board provide feedback on the proposed redevelopment and highlight areas of concern that may be addressed by the Planning and Zoning Commission.

The Decision by the Board was to move this forward to the Planning and Zoning Commission.

C. **An Ordinance Suspending Permits Fees for a Temporary Sign**

**Summary:** As a means to help businesses that are being negatively impacted by local road construction, the proposed Ordinance would allow the Village to waive the \$110 temporary sign fee for properties adjacent to construction areas. This

includes the Ela Road / Rand Road intersection project which impacts businesses in the Village Square Shopping Center and the shopping center west of Ela Road and south of Route 22.

Mr. Johns Sfire of Fidelity Group, explained to the Board the reason for his company's request. The Board's questions were answered by the staff including the clarification that it is for properties adjacent to construction areas and not village wide.

**\*E. Approval to Waive the Bid Process and Accept the Proposal from Berger Excavating in the Amount Not-to-Exceed \$611,230.00 for Emergency Replacement of an Estimated 600 Feet of Sewer to the Village's Sanitary Sewer Transmission Line**

**Summary:** On Saturday, September 19, a 14-foot section of the Village's sanitary sewer transmission line collapsed. This section of sewer is located in Long Grove on East Cuba Road about 500 feet west of Old McHenry Road. A temporary repair has been made and emergency approval is requested to replace approximately 600 feet of sanitary sewer. Funds have been set aside in the FY 2016 budget for a sewer lining project, which coincidentally is addressed in agenda item 6D on the consent agenda tonight. Village Board approval is requested to waive the bid process and approve an estimate in the amount of \$611,230.00 from Berger Excavating to provide emergency repair services.

Community Services Dir. Mike Earl described the issue with the collapse of the sewer line. Manhard Consulting Engineer Peter Stoehr gave a presentation of the break and proposed repair. Mr. Stoehr answered the Board's questions. Mr. Earl thanked Mike Brown, Steve Schmitt and staff for their weekend work.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and the Board of Trustees of the Village of Lake Zurich, Lake County, Illinois, as follows:

**SECTION 1:** The number of Class **B** liquor licenses authorized by section 3-3b-14 of Chapter 3 of title 3 of the Village Code of the Village of Lake Zurich is hereby **increased** by one for Tracy's located at 790 South Rand Road in accordance with the Village Code of the Village of Lake Zurich. Issuance of the license is subject to the approval and action of the Local Liquor Commissioner of the Village of Lake Zurich.

**SECTION 2:** If any section, paragraph, clause or provision of this Ordinance shall be invalid, the invalidity thereof shall not affect any of the other provisions of this Ordinance.

**SECTION 3:** All Ordinances in conflict therewith are hereby repealed to the extent of such conflict.

**SECTION 4:** This Ordinance shall be in full force and effect from and after its passage, approval and publication as provided by law.

Subject: Intergovernmental Agreement for Warning Siren Activation-Deer Park, IL

**Issue:** In the summer of 2012, the Village of Deer Park engaged in conversations with the Lake Zurich Fire Rescue Department Emergency Management Director to discuss the need of an outdoor-warning siren in their Village.

**Analysis:** The Lake Zurich Fire Rescue Department, in contract with the Lake Zurich Rural Fire Protection District, provides Fire, EMS, Specialty, and Inspection Services to the majority of the Village of Deer Park. This collaborative relationship lent itself to the conversation that the Village of Lake Zurich and the Fire Rescue Department be the authority having jurisdiction to authorize the activation of Deer Parks' Outdoor Warning Notification Sirens. Deer Park has reviewed Lake Zurich's policy, procedures, and general orders and agreed with our methodology.

In the summer of 2015, Fire Rescue Staff worked with Deer Park officials, to inform their board of our intent and that Lake Zurich desires cooperation in the interest of public safety of all residents and visitors on our contiguous boarder.

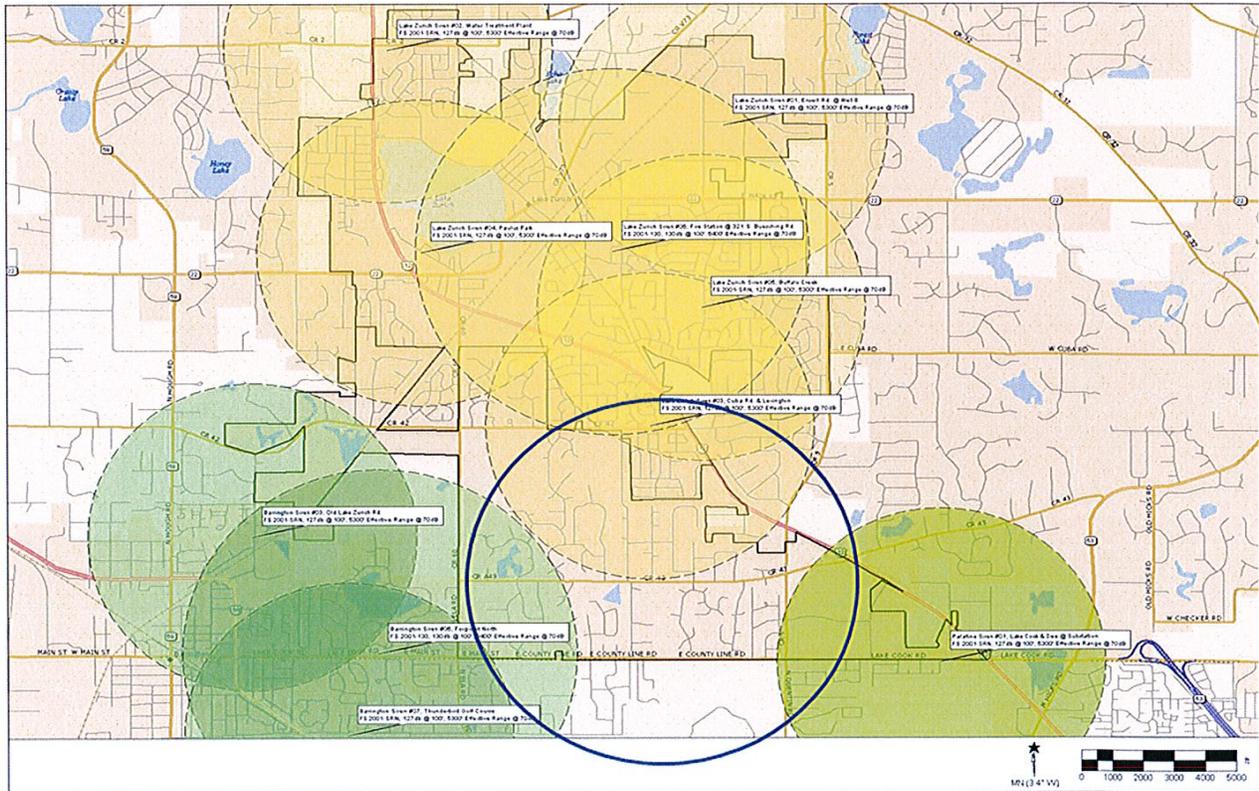
Deer Park has since ordered and installed equipment, which they own, maintain, and provide service to in the Charlie Brown Public Park located on Long Grove road.

**INTERGOVERNMENTAL AGREEMENT BETWEEN THE VILLAGES  
OF DEER PARK AND LAKE ZURICH, ILLINOIS, FOR THE  
INSTALLATION AND CONNECTION OF A WARNING SIREN  
LOCATED AT CHARLIE BROWN PARK**

This Intergovernmental Agreement (hereinafter, "Agreement") is entered into this \_\_\_\_\_ day of \_\_\_\_\_, 2015, by and between the Village of Deer Park, an Illinois municipal corporation (hereinafter referred to as "Deer Park") and the Village of Lake Zurich an Illinois municipal corporation (hereinafter referred to as "Lake Zurich").

**RECITALS**

WHEREAS, Deer Park is a municipality lawfully organized and existing under the Constitution and laws of the State of Illinois; and,

WHEREAS, Lake Zurich is a municipality lawfully organized and existing under the Constitution and laws of the State of Illinois; and,

WHEREAS, Article VII, Section 10 of the 1970 Constitution of the State of Illinois provides that units of local government may contract among themselves, to obtain or share services and to exercise, combine or transfer any power or function, in any manner not prohibited by law or by ordinance; and,

WHEREAS, the Illinois Intergovernmental Cooperation Act, 5 ILCS 220/1, et. seq. provides additional powers to units of local government to work together; and

WHEREAS, Deer Park desires to warn its residents of possible threatening weather by installing a warning siren at Charlie Brown Park located at 23146 Long Grove Rd, Deer Park, IL 60010, (hereinafter referred to as the "Park"); and

WHEREAS, Deer Park agrees to incur all the expenses related to the purchase and installation of a warning siren at the Park; and

WHEREAS, Deer Park shall permit the Lake Zurich access to the Park to connect the warning siren to its severe weather activation system (hereinafter referred to as the “activation system”), and permit Lake Zurich access to the Park in order to establish and maintain the connection to the activation system; and

WHEREAS, Deer Park has been provided a copy of Lake Zurich’s policy, entitled Severe Weather Operations, which outlines the methodology and activation of its sirens, and agrees to said methodology and activation of its sirens. Lake Zurich’s policy, entitled severe Weather Operations, is attached hereto and incorporated herein as **Exhibit A**; and

WHEREAS, Lake Zurich shall permit Deer Park’s warning siren to be connected to the activation system; and

NOW, THEREFORE, in consideration of the mutual agreements contained herein and upon the further consideration of the recitals hereinabove set forth, it is hereby agreed by and between the parties as follows:

**SECTION I: INCORPORATION OF PREAMBLE RECITALS.** The above preamble recitals are incorporated herein by reference as though fully set forth.

**SECTION II: INSTALLATION OF A WARNING SIREN AT THE PARK.** The purpose of this Agreement is to provide Deer Park with the ability to connect a severe weather warning siren to Lake Zurich’s severe weather warning activation system (hereinafter referred to as the activation system). Accordingly, Lake Zurich permits Deer Park’s warning siren, which Deer Park shall purchase, install, and maintain, at its sole cost and expense, to be connected to the activation system. Any costs associated with establishing and maintaining the connection of the Deer Park warning siren to the activation system shall be the sole responsibility of Deer Park.

**SECTION III: ACCESS TO THE WARNING SIREN.** Deer Park authorizes Lake Zurich's officers, contractors, agents and employees to access the Park to establish and maintain the connection of Deer Park's warning siren to Lake Zurich's activation system.

**SECTION IV: EFFECTIVE DATE.** This Agreement shall be effective immediately after obtaining approval by the Deer Park Village Board of Trustees and the Lake Zurich Board of Trustees.

**SECTION V: DURATION.** This Agreement shall continue in full force and effect until Deer Park and/or Lake Zurich takes lawful action to, terminate this Agreement. Either party may terminate this Agreement for any cause, or no cause, by serving written notice of cancellation upon the other party upon thirty (30) days notice of such cancellation. In the event of termination of this Agreement, Deer Park shall be responsible for disconnecting its warning siren from the activation system, at its sole cost and expense.

**SECTION VI: INDEMNIFICATION.** Deer Park agrees to indemnify and hold harmless Lake Zurich, its Board, individual Board members, and its affiliates, officers, agents, volunteers, and employees (the "Indemnified Parties") from any and all liabilities, damages (regardless of type or amount), claims, causes of action, demands, actions, costs, penalties, suits or matters, including attorneys' fees and court costs, to the extent arising from a breach of this Agreement by Lake Zurich, and to the extent arising from any intentional, reckless or negligent act or omission of Deer Park, its employees or its contractors

**SECTION VII: INSURANCE.** Deer Park shall procure and maintain, through an insurance company or companies licensed to conduct business in Illinois, insurance with coverage and limits as specified below, and shall cause Lake Zurich, its Board, individual Board members, officers, employees, agents, representatives, and volunteers, to be named as additional insureds on these policies by endorsement. All such insurers shall carry a Best Key Guide

Rating of A / XV. The commercial general liability and automobile liability policies shall be endorsed to reflect that coverage is primary to and noncontributory with any other insurance available to Lake Zurich. The commercial general liability policy shall, by endorsement, provide contractual liability coverage, including the indemnity obligations provided in this Agreement. Each such policy shall include, by endorsement, a requirement of at least thirty (30) days' written notice to Lake Zurich prior to any termination or cancellation of or material amendment to that policy. Upon execution of this Agreement, and on an annual basis thereafter during the term of this Agreement or any extension thereof, Deer Park shall furnish to Lake Zurich certificate(s) of insurance, policies, and endorsements reflecting the required coverage. The type and minimum limits of insurance required are as follows:

**SECTION VIII: COST.** There is no cost to Deer Park for receiving the signal for the Warning Siren or for maintaining dispatch for same.

**SECTION IX: POLICY.** Deer Park agrees with Lake Zurich's methodology and activation of its sirens outlined in Exhibit A.

**SECTION X: SEVERABILITY.** If any part of this Agreement shall be held invalid for any reason, the remainder of this Agreement shall remain valid to the maximum extent permitted by law.

**SECTION XI: RELATIONSHIP OF PARTIES.** Nothing in this Agreement is intended or shall be construed as establishing a separate legal entity, or the relationship of principal and agent, partnership, or joint venture between or among the parties. Each party hereto shall retain the sole right to control its own employees, and the affairs and conduct of its employees and representatives, including the payment of compensation and benefits, shall be sole responsibility of the respective party

**SECTION XII: PRIOR AGREEMENTS.** This Agreement supersedes all oral agreements and negotiations between the parties hereto relating to the subject matter hereof as well as any previous agreements presently in effect between the parties hereto relating to the subject matter hereof.

**SECTION XIII: AMENDMENTS.** Any alterations, amendments, deletions, or waivers of any provisions of this Agreement shall be valid only when expressed in writing and duly executed by the parties hereto.

**SECTION XIV: SUCCESSORS AND ASSIGNS.** This Agreement shall be binding upon and inure to the benefit of the parties hereto, their successors and assigns, provided however, that neither party hereto shall assign any interest hereunder without the prior written consent and approval of the other and any such assignment, without prior written consent and approval shall be null and void and of no force and effect.

**SECTION XV: NOTICES.** Any notices required or permitted hereunder shall be sufficiently given if mailed by certified mail, return receipt requested to the parties hereto as follow:

Subject: Emergency Sewer Repair Funding

**Issue:** The recent failure of the sanitary transmission line under East Cuba Road, near Old McHenry Road, has proven to be a costly repair. Estimates for emergency repairs are still being prepared, but will likely be significantly more than the \$611,230 previously approved by the Village Board. As a large unbudgeted expense, staff is evaluating all options for funding the repairs. The attached ordinance allows the village the flexibility to pursue the option of issuing debt as a funding source.

**Analysis:** At the September 21, 2015 board meeting, the Village Board authorized Berger Excavating to proceed with emergency sewer repairs in an amount not-to-exceed \$611,230. Subsequent to the meeting, additional sections of the sewer pipe were televised, identifying additional sections in need of serious repairs. The pipe has deteriorated beyond the point where lining is possible. Taking advantage of the opportunity to repair the larger section at once will allow for some economy of scale and save the village money in the long run. Staff from both the village and Manhard Engineering expect that the plans for the exact length of pipe needing replacement, scope of bypass pumping, and traffic detour plans will be finalized in the next few days.

Current estimates are that the project costs will exceed \$1 million. Unfortunately, this high an expense cannot be absorbed by the Water and Sewer fund without serious detriment to other critical capital projects. There is a strong possibility the village will need to issue debt in order to fund the sewer repairs. As such, staff is proposing an ordinance for village board consideration and approval that would protect the village's option of issuing debt after the repairs have been completed. The ordinance states a maximum of \$1.5 million in principal. This is

higher than the current estimate and will allow for any additional unknown expenses. Any actual debt would be issued for the final determined amount.

The ordinance does not authorize the debt issuance, or guarantee the village will issue debt. It merely provides the opportunity for the village to authorize debt at a future date to cover expenses from these repairs. Without such ordinance, the village would only have a sixty (60) day window in which to issue the debt. Staff will bring forth any proposed debt issuance at a later date if necessary, once the project plan has been completed.

Should any additional questions arise, staff from Finance and/or Community Services are both available.

**Recommendation:** Staff recommends the Village Board approve the Ordinance expressing official intent regarding certain capital expenditures to be reimbursed from proceeds of an obligation to be issued by the Village of Lake Zurich.

Severability.* If any section, paragraph, clause or provision of this Ordinance shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such section, paragraph, clause or provision shall not affect any of the remaining provisions of this Ordinance.

*Section 6. Repeal.* All ordinances or parts thereof in conflict herewith be and the same are hereby repealed and this Ordinance shall be in full force and effect forthwith upon its adoption.

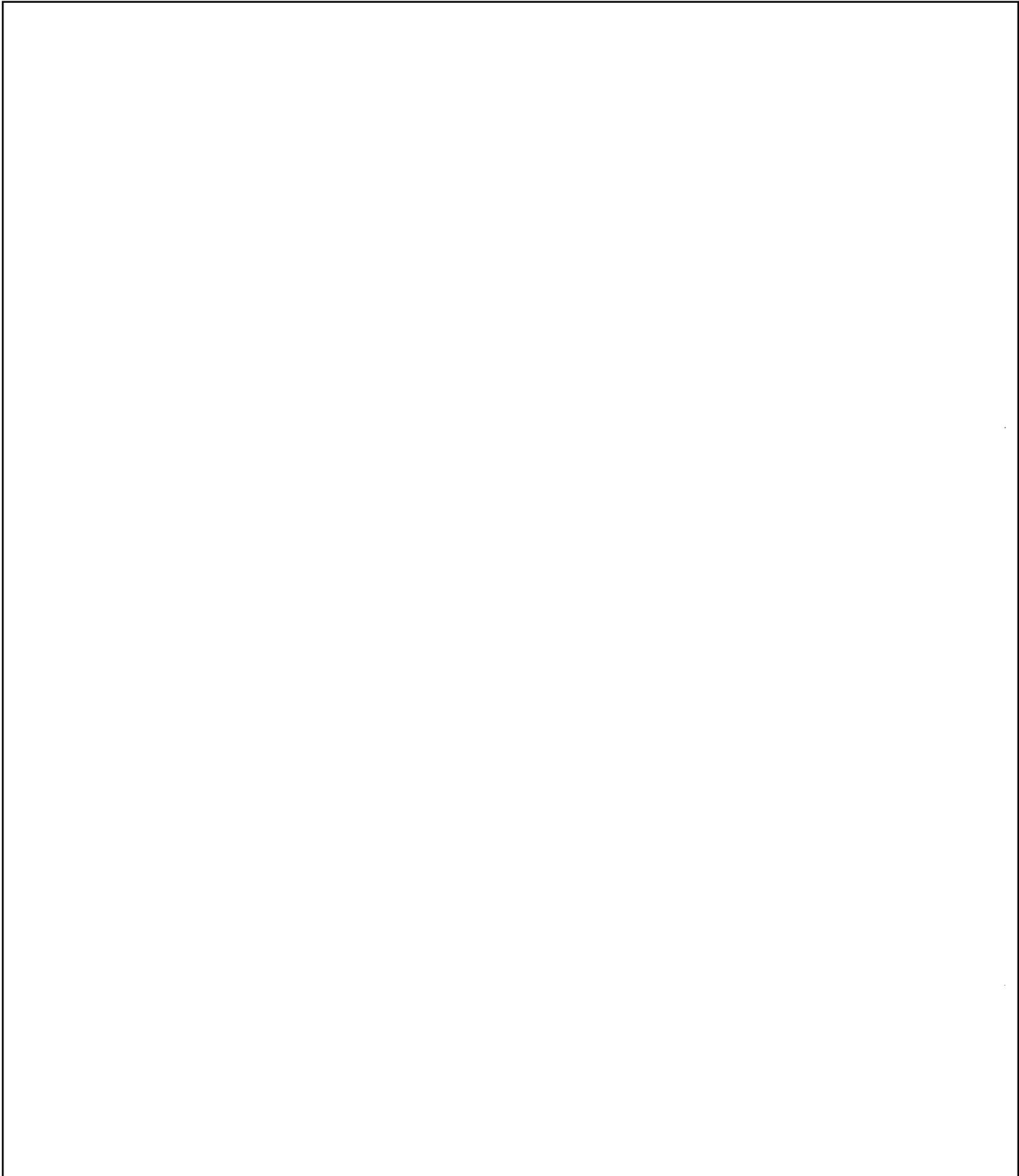
