**All Natural Hazards Mitigation Plan** 

**Issue:** The Lake County All Natural Hazards Mitigation Plan has been conditionally approved by the Illinois Emergency Management Agency and Federal Emergency Management Agency (FEMA). The Plan now requires Lake County municipalities to adopt it before it can be considered fully approved.

**2014-2019 Strategic Plan:** This agenda item addresses Lake Zurich *Strategic Goal #3 Infrastructure:* 

*Objective*: Address issues of storm water management, including detention pond maintenance and preservation of wetlands and green space.

**Background**: In 2006, Lake County and participating Lake County municipalities developed and adopted the first Countywide All Natural Hazards Mitigation Plan. FEMA requires that a community develop and adopt a FEMA-approved hazards mitigation plan in order to be eligible for hazard mitigation grant funds. This plan is required to be updated and re-adopted every five years to maintain grant eligibility.

**Natural Disasters:** Lake County is subject to a wide array of natural disasters at any time of the year. In recent years Lake County has been impacted by:

- Major flood events in 1979, 1982, 1986, 1993, 1996, 2000, 2004, 2008 and 2013
- Since 1957, a total of 16 tornadoes have touched down



- Severe thunderstorms in 1996, 1998, 2002, 2007 and 2011
- Winder blizzards in 1999, 2000, and 2008
- Large wildfires in 2003 and 2005
- Extreme heat wave impacting the young and elderly in 1999

The committee that put the Plan together reviewed all potential natural hazards that could impact Lake County and evaluated them based on causes, likelihood of occurring, and their impact on people and property. The highest threat to health and safety of people is a power outage, drought, and tornado. The highest threat to buildings are floods and tornados. The highest threat to the economy is floods.

**Recommendation:** Approve the Resolution adopting the 2017 Lake County update to the All Natural Hazards Mitigation Plan and implement its recommendations as resources become available.
