Subject: **Akhando Hum Inc. dba/Stompin' Grounds Café – Class W Liquor License**

**Issue:** Akhando Hum Inc. dba/Stompin' Grounds Café, located at 64 N. Old Rand Road, is opening a boutique restaurant and is requesting a Class W (on-premises consumption and retail sale of wine and sparkling alcoholic beverage) liquor license from the Village.

**Analysis:** Upon issuance of this *Class W – Wine and sparkling alcoholic beverage license* liquor license from the Village, Stompin' Grounds Café, will be authorized to serve alcoholic beverages for consumption on premises and for off premises consumption.

Stompin' Grounds Café. has submitted the requisite application, certificate of insurance, incorporation documents, employee handbook, proof of BASSETT certification and completed a background check, to be issued a Village of Lake Zurich liquor license.

**Recommendation:** Approval of the proposed Ordinance.

**ORDINANCE AMENDING TITLE 3 OF CHAPTER 3 OF THE VILLAGE OF LAKE ZURICH MUNICIPAL CODE TO INCREASE AUTHORIZED CLASS W LIQUOR LICENSES FOR AKHANDO HUM INC. DBA/STOMPIN' GROUNDS CAFÉ' AT 64 NORTH OLD RAND ROAD AND REVOKING CLASS A AND CLASS V LIQUOR LICENSES FOR MOLLY'S PANCAKES AT 572 WEST ROUTE 22**

**NOW, THEREFORE, BE IT ORDAINED** by the Mayor and the Board of Trustees of the Village of Lake Zurich, Lake County, Illinois, as follows:

**SECTION 1:** The number of **Class W** liquor licenses authorized by section 3-3b-14 of Chapter 3 of Title 3 of the Village Code of the Village of Lake Zurich is hereby **increased** by one for **Akhando Hum, Inc. dba/Stompin' Grounds Café'**, located at **64 North Old Rand Road** in accordance with the Village Code of the Village of Lake Zurich. Issuance of the license is subject to the approval and action of the Local Liquor Commissioner of the Village of Lake Zurich.

**SECTION 2:** The number of **Class A** liquor licenses authorized by section 3-3b-14 of Chapter 3 of Title 3 of the Village Code of the Village of Lake Zurich is hereby **decreased** by one for **Molly's Pancakes**, located at **572 West Route 22** in accordance with the Village Code of the Village of Lake Zurich.

**SECTION 3:** The number of **Class V** liquor licenses authorized by section 3-3b-14 of Chapter 3 of Title 3 of the Village Code of the Village of Lake Zurich is hereby **decreased** by one for **Molly's Pancakes**, located at **572 West Route 22** in accordance with the Village Code of the Village of Lake Zurich.

**SECTION 4:** That Section 3-3B-14 of Chapter 3 of Title 3 of the Lake Zurich Municipal Code entitled "NUMBER OF LICENSES" be and is hereby further amended with the corresponding number of licenses in each class, shown with bold letters with underscoring below:

**SECTION 5:** If any section, paragraph, clause or provision of this Ordinance shall be invalid, the invalidity thereof shall not affect any of the other provisions of this Ordinance.

**SECTION 6:** That if any provision of this ordinance or application thereof to any entity or person or circumstance is declared invalid or held to be unlawful, such declaration or holding shall not affect the validity of any other portion or provision of this Ordinance and such declaration or holding shall be severable from the remainder hereof.

**SECTION 7:** This Ordinance shall be in full force and effect immediately upon its passage and approval as provided by law.
